Registration Certificate for Recycler / Processing of Plastic Waste
(Under Rule 13(3) of the Plastic Waste Management (Amended) Rules, 2018)

Sub: PCB - Plastic Waste Management (Amended) Rules, 2018 – Grant of Registration - Reg.

Ref: Your application in Form-II dated 14.11.2019 seeking registration of Units for processing or Recycling of Plastic Waste.

The Telangana State Pollution Control Board after examining the application, hereby issues registration to **M/s. Pyrogreen Energy Private Ltd., Shed No.16, Phase – 3, IDA Patancheru, Sangareddy District** under Rule 13(3) of Plastic Waste Management (Amended) Rules, 2018 for registration of the facility engaged in Processing or Recycling of Plastic Waste – 3 TPD.

This certificate of registration shall be valid up to **31.10.2024** unless revoked or suspended.

The certificate is granted subject to the following terms and conditions:

1. The Registration as a "Recycler" shall comply with the provisions of Rule No. 13(3) of the Plastic Waste Management (Amended) Rules, 2018.
2. The Recycler shall establish and operate the waste processing facility and adhere to the provisions of the PWM (Amended) Rules, 2018.
3. The Recycler shall collect the recyclable plastic waste and process the same. The non-recyclable plastic waste i.e., multilayered plastic shall be segregated and disposed to Cement Units for energy recovery.
4. The Plastic waste which is non-recyclable or non-energy recoverable or with no alternate use of plastic if any should be phased out in two years time.
5. Every recycler shall submit annual returns under Rule 17(1) of PWM (Amended) Rules, 2018 before 30th April of every year to the concerned local body under intimation to the TSPCB.
6. The registration shall be in force subject to valid consent under the Water (Prevention and Control of Pollution) Act, 1974 as amended and Air (Prevention and Control of Pollution) Act, 1981 as amended and authorization under Solid Waste Management Rules, 2016.
7. Any change in the process technology, as given in the application shall not be carried out in accordance with prior permission of the Board.
8. The Telangana Pollution Control Board may, at any time, revoke / stipulate any of the conditions applicable under the Registration and shall communicate the same in writing.

9. The industry shall follow all the provisions of Plastic Waste Management (Amended) Rules, 2018. Any violation of provisions of these Rules and amendments thereof will attract the penal provision of the Environment (Protection) Act, 1986.
10. The facility shall apply for renewal of Registration atleast 120 days prior to the expiry of the Registration.
